**Subject: Call for volunteers to support the quality of INTOSAI's standards - 2026**

Dear colleague,

The Forum for Professional Pronouncements (FIPP) comprises 16 volunteer members who play a key role in the process of ensuring the quality of INTOSAI's pronouncements. With this letter, we invite SAIs to participate in this important work by nominating candidates for **one immediate vacancy** in FIPP and for a reserve list for future appointments.

Standard setting is one of INTOSAI's most strategically important and visible activities. One important way to make standards fit-for-purpose and relevant for users, is to recruit members to FIPP from different SAIs, INTOSAI bodies and from as many INTOSAI regions as possible. By nominating a candidate for FIPP your SAI will get a better understanding of how standards are developed and will have global increased visibility. Thanks to their work at FIPP, your staff member will also develop a unique knowledge of audit practice around the world and as such be a valuable resource for further professionalisation in your own SAI.

Over the coming months, we aim to recruit **one new member** from the SAI community to start approximately in late April 2026. Additionally, we will establish a reserve list of committed and interested candidates for future appointments in 2026–2027, should vacancies arise. This reserve list will be valid for one year after notification to the PSC-SC meeting, estimated to take place in April 2026, and endorsement by the Governing Board. FIPP members are nominated for an initial, renewable, three-year period.

Being a FIPP member requires around 300 hours of work annually, including participation in regular online meetings and 1-2 in-person meetings per year. In general, we look for candidates:

- With a solid understanding of the framework IFPP
- With solid experience in auditing
- With experience in standard-setting
- Committed to work on behalf of INTOSAI
- With a high level of proficiency in English, and
- Willing to spend the necessary time to participate in this important work.

For the new member starting in April 2026, we are looking for a candidate who in addition has strategic managerial experience.

More information on how FIPP operates can be found in Annex I.

We plan to interview the most suitable candidates to understand their motivation, experience, and knowledge. In selecting successful candidates, we aim to ensure that FIPP has the best balance of

knowledge, skills and expertise, and is broadly representative of the INTOSAI community. Further details on the application process are given in Annex II.

We aim to receive applications from the widest possible range of candidates, and for this round we are particularly keen on welcoming applicants with previous experience in and a good working knowledge of standard-setting from within a recognised standard-setting body. The deadline for submissions is February 13<sup>th</sup>, 2026.
